6. New Business

6. A. GBV National Action Plan

- Brought to us by Rifaa Carter (KAVAC)
- YWCA has an opportunity for funding. They have a list of 69 organizations they are working with and they do have the capacity of working with a few more so if KFACC would like funds to host some community engagement sessions directly they are open to connecting. They can connect Rifaa with their team to get the process started and share what is needed to make that possible.
- They would require audited financial statements, a certificate of insurance and a signed agency agreement. If KFACC as an organization cannot directly participate, than we can work with a trustee organization. The YWCA is open-minded and we would not be the only organization needing to partner due to the insurance etc.
- They have offered funding to Kingston but it needs to be acted on immediately as our information needs to back to them by March 16th to qualify
- KFACC would need to partner with an agency to meet the criteria regarding insurance, NFP or charity number, etc. to sign off on the contract
- KAVAC would like to work on it with a trusted organization; KAVAC would do the main work and documentation to reply by March 16th and the paperwork for government reporting in April.
- Would survey groups/communities they are trying to reach, those that are under heard and underserved; would run surveys and focus groups. Maximum \$40,000 funding for the regional area
- Victim Services is interested in partnering with KAVAC as the trustee agency
- Rifaa and Deirdre will send the information to Paula and Kim to review; they will need to hear back by mid-morning Friday March 5th as they will need to send a confirmation to the GBV National Action Plan group by mid-afternoon Friday March 5th to begin the process

6. B. Fiscal Year End

- \$3900 extra funding has been allocated to the EAC Workgroup to conduct a media blitz "Still Here For You". Ads on 50 Kingston Transit buses, article and ad in the Kingstonist and social media boosts. No additional funds are needed at this time.
- Estimate of \$3005 left to spend in the regular budget before fiscal year end. Potential uses as voted in priority:
 - #1 Website update audit has started and the consultant discussion with the Administrative Group is being booked
 - #2 Additional funds for the media blitz
 - #3 Down payment for the TEND training
 - o #4 Donate to Building a Bigger Wave
