Safety Planning Workgroup

⇒ The Risk Assessment Checklist is on final review

• Diversity Workgroup

- ⇒ Is developing an online module based on OAITH information
- ⇒ Looking at holding a Lunch N Learn in the Fall re: creating safe and inclusive spaces at the agencies and KFACC

Communication & Media Workgroup

⇒ Budget/Timeline is being reviewed and focus is on getting back on track with the video journey.

Public Education & Advocacy Workgroup

- ⇒ KLA Working Group wants to be involved in HT training and advocacy looking at starting a new working group that crosses out of KFACC
 - New group including other organizations that will coordinate various groups including such as the Limestone District School Board, agencies from Lennox & Addington, shelters, OPP etc.
 - Are drafting TOR for new group
 - Not looking at financial support from KFACC at this time
 - Looking at developing a Protocol for our region (looking at 2 examples from the Durham region)
- ⇒ Child Abuse Protocol is in the final stages and includes crossover with HT
 - Question raised re: changing the mandate of KFACC to include HT and Child Abuse?
 - Child Abuse Protocol is at present it stripped down Signatories are being kept to those directly involved (Justice/School Boards/FACSFLA).
- ⇒ KFACC Administrative Group: KFACC mandate change to include involvement in Human Trafficking Protocol and Child Abuse Protocol?
- ⇒ Theatre Involvement Request: Anna to send the information to the Chair of the Public Education & Advocacy Workgroup and forward the email to the School Boards

Protocol Workgroup

- ⇒ Met a month ago
- ⇒ Holding interactive training sessions on partner abuse and sexual assault on the 13, 14, 15 of November with 3 more dates in January.

KAVAC

- ⇒ Have developed abuse information leaflets and pamphlets which are going out to Doctor's offices and Schools
