2. Acknowledgement

7. A. KFACC Social Media Campaign 2024 Ideas

- Barb Lotan (Queen's) - The safe use of Rideshares and Uber was a good one, can we update the graphics and reuse as it is always applicable, especially to post-secondary students
 - Sheryl Rathwell (Maltby) - Also send it to the Limestone and Algonquin School Boards as it's applicable to secondary school students as well
 - Melissa Kerr (SLC) – Look at translating it to other languages such as Punjabi and Urdu as there are large student populations who speak other than French and English
- Sheryl Rathwell (Maltby) - We should also look at having a high school targeted campaign for ages 15 – 21
- Leigh Martins (KIH) - Healthy Relationships. There are many angles that can cross from secondary to post-secondary such as:
 - For parents/caregivers – what signs to look for
 - What to do to keep your kids safe
 - Questions/answers for kids
 - How SA/IPV/GBV impacts specific populations
- Revamp/update the “Still Here For You” campaign
- Look at “Springtime” i.e. proms, dances and outdoor events; unsupervised time with peers increase in the Spring
 - Use a dance motif
 - Safe use of alcohol and drugs i.e. Watch your drinks/don't take street drugs
 - Boundaries – “What Are Boundaries?” i.e. You Are Allowed To Say No and Dealing With Rejection
- Homecoming Campaign - Queen's in October
 - Keep in mind the backlash that happened when an anti-drinking campaign was held for St. Patrick's Day. It would need to be worded carefully to have a positive impact

- “Stay Grounded” with photos of people on top of roofs and garages

70 Officers have been trained with another approximately 30 more patrol Officers to be trained, along with some Sergeants
